Resolution No. 171/1/2019

Concerning the formation of a committee to manage the “Lebanese Federation for Diving and Rescue”

The Minister of Youth and Sports,

Pursuant to Decree No. 4340 dated 31/01/2019 (government formation)

Pursuant to Law No. 247 dated 07/08/2000 (merging, abolishing and establishing ministries and councils)

Pursuant to Law No. 629 dated 20/11/2004 (organizing the Ministry of Youth and Sports)

Pursuant to Decree No. 4481 dated 27/10/2016 (organizing the sports, youth and scouting movement)

Pursuant to the suggestion of the Director General of Youth and Sports

Decides the following:

Article 1: A committee for the management of diving and rescue shall be formed from:

Article 2: The committee's mission is determined by:

- 1- Organizing, supervising and disseminating the affairs related to the sport of “diving and rescue” and encouraging its practice in Lebanon.
- 2- Representing Lebanon abroad and participating at the Arab, regional, continental and international levels, in accordance with the laws and regulations in force.
- 3- Holding sports championships and activities annually.
- 4- Promoting sport at the Arab, regional, continental and international levels.

Article 3: During the exercise of its duties, and in order to achieve its goal, the committee has the right to accept donations, financial and in-kind aids, open accounts and manage movable and immovable properties and use them according to the procedures in force and within the laws in force.

Article 4: The period of the committee's mandate is limited to two years starting from the date of this decision. All provisions that violate it and which are inconsistent with its content are canceled, provided that the committee submits quarterly administrative, financial and technical reports on the results of its work to the Sports Directorate - Ministry of Youth and Sports.

Article 5: This decision is published and notified to whom it may concern.
